Prices include Golf Ontario fee and BCC Activity Fee;

2018 BCC members are “current members” and not considered “returning members”

2018 Fall Golf and 2019 Golf Membership

Dear Fellow Golfers,

Thank you for your interest in the Brockville Country Club, a fantastic well-groomed Stanley Thompson 18 hole layout that was founded as a 9 hole golf course in 1914 then amalgamated in 1976 with the Brockville Curling Club to become the multi-sport club that it is today. Between the two activities the club has over 600 members that either participate in one or both of the sports. The club also offers a Social Membership that allows individuals to enjoy the camaraderie of the club as well as participate in golf and or curling on a part time basis.

The club is a member owned non-profit organization that has a Board of Directors with representation from all activities and demographics of the club. From an operational stand point, the club's Management team is led by the General Manager, and includes Director of Sports Operations, Golf Superintendent, Ice Maker, Club Services Coordinator, Food & Beverage Manager, Head Chef and Property Manager.

The club offers an eclectic social calendar that attracts members and their guests to club events throughout the year. Members are welcome to use their club to host personal and or corporate special events like business lunches, wedding receptions, special birthdays etc. As well, both the golf and curling divisions offer everything from Men's and Ladies' Nights, League play, club championships and many events for members and their guests. Golf Memberships include club storage and unlimited driving range and short game practice area use.

The Brockville Country Club is offering a 2018 fall membership that will be credited towards a full 2019 golf membership. Here is how it works>>>> you pay \$700* + HST to golf the remainder of the 2018 season. If you join for the 2019 golf season by the end of January 2019 this \$700 will be credited towards your 2019 membership fees, so you would end up getting 2018 fall golf at no charge!

* \$350 for a current Flex Golfer; \$500 for an Intermediate (<39 yrs); \$600 for a Keystorm Fun Leaguer.

Example: Full membership for a new member** (40+ years) is \$1,900 + HST so you would pay \$700 + HST for the fall and another \$1,200 + HST for the 2019 season. If you decide not to join for the 2019 season then you have received unlimited fall golf for \$700 + HST.

** offered to first time BCC members and returning members from 2016 and earlier. Other returning members will pay a total of \$2,150 + HST.

Following this page is a Membership Application and a BCC Credit Agreement. The latter only needs to be submitted if you would like to have charging privileges when at the club. Members are more than welcome to pay as they go when at the club.

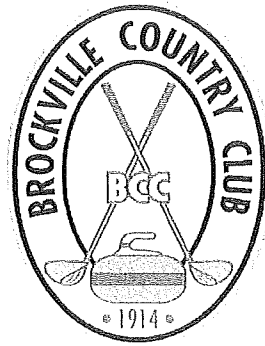
